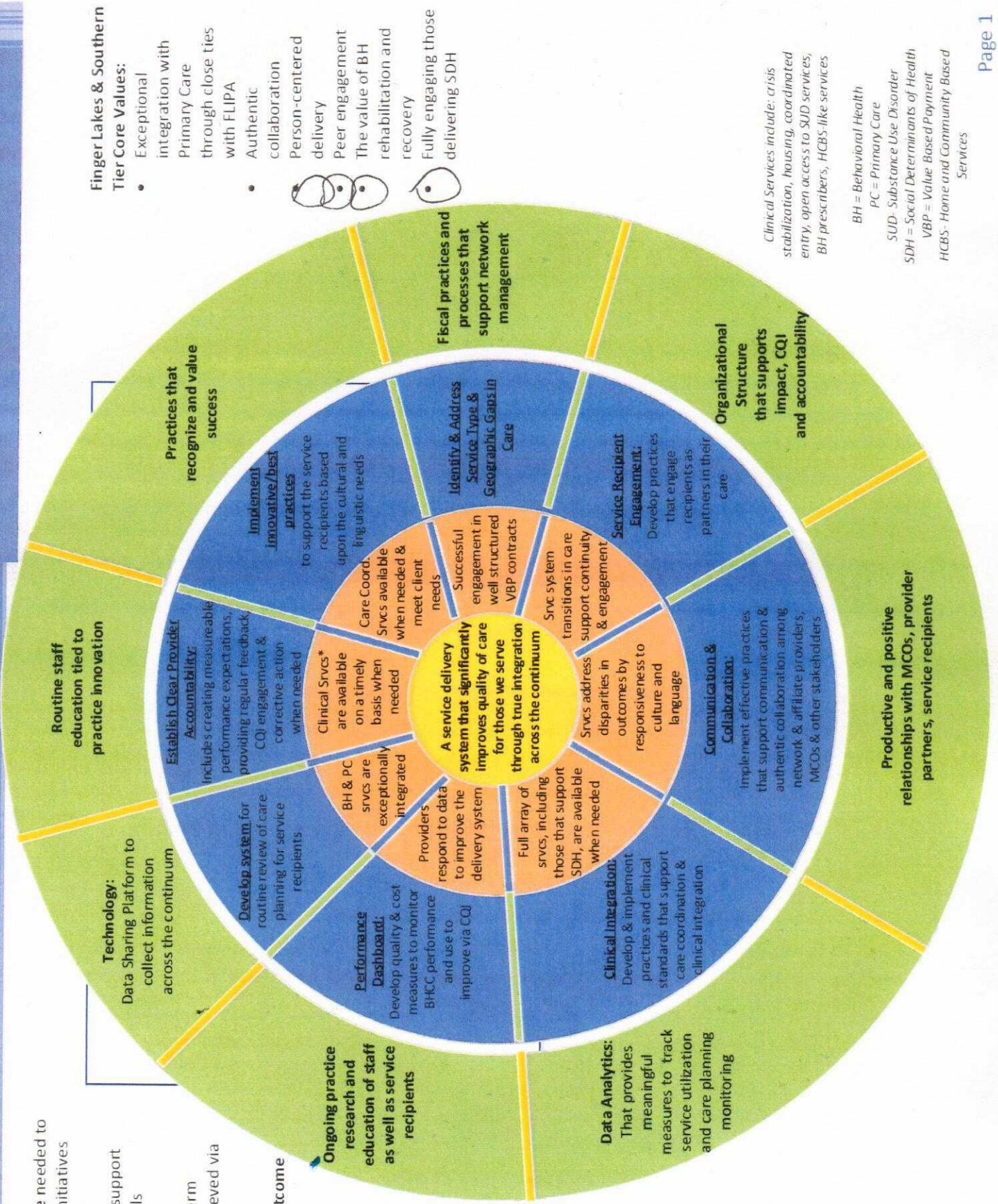

 HCBS = Home and Community Based Services
