General Description

Reporting to the Executive Director (ED), the Economic Empowerment Director will perform complex, professional-level assignments in economic development, including business recruitment, job development, and business retention strategies; conduct research and provide analysis on matters of economic health; and serve as the primary contact for neighborhood businesses. He/she should be charismatic and highly organized; have superb written and oral communication skills, including comfort with public speaking and external relations; be technologically savvy; be a strong researcher and editor; have immaculate attention to detail; be able to multi-task and accomplish deadlines, and be energetic and committed to achieving results.

Core Responsibilities

- Manages the implementation of the neighborhood economic empowerment priorities, including business creation, attraction, retention, assistance, and promotion
- Communicates and coordinates with business owners interested in establishing or growing businesses in the neighborhood
- Keeps abreast of legislative developments which may impact economic development programs, policies, and/or procedures
- Supports and co-facilitates the establishment of a viable neighborhood business association
- Attends various commission and City Council meetings, business development meetings, and stakeholder meetings
- Analyzes economic data and prepares reports, including business and financial forecasts; makes
 presentations to businesses and community groups
- Works closely with the Neighborhood Hub Director to coordinate and market key economic empowerment programs/opportunities for emerging entrepreneurs and business owners
- Co-Facilitates and Prepares agendas for the Economic Empowerment Committee
- Works closely and collaboratively with the City's Neighborhood and Business Development Department, economic development partners, and Comprehensive Neighborhood Plan anchor partners

Director of Housing and Asset Management

General Description

The Director of Housing and Asset Management will oversee the complete portfolio of Connected Communities subsidiary, CC Special Projects, LLC. This position is responsible for planning, developing, and managing all property and affordable housing development activities. Additionally, this position will be the administrator for housing-related programs such as the Landlord Fund and the Emergency Housing Fund. The Director of Housing and Asset Management will maintain a relationship with third-party management companies and other asset management-related contractors. The Director of Housing and Asset Management is responsible for supporting the preservation of affordability in Beechwood and EMMA and directing continual improvements to our portfolio's economic performance; ensuring consistent compliance with funders; maintaining the properties' physical upkeep and curb appeal; and coordinating with the Neighborhood Hub Director to ensure resident access to services and programming. This role reports to the Executive Director.

Core Responsibilities

- Evaluate the feasibility of potential development opportunities, conceptualize a development program in concert with the organizational mission and goals, and make recommendations to the Executive Director.
- Maintains database of entity status, oversees the dissolution of entities no longer in use, and works with development partners on the formation of new entities.
- Works with the Director of Resource Development to prepare and submit funding applications to secure funding to support predevelopment, construction, and permanent phases for development.
- Represents Connected Communities to stakeholders and the general public. Strategizes and plans outreach to garner community support for projects. Attends and participates in neighborhood associations and other community and government organization meetings as needed.
- Regularly assess the housing needs of vulnerable populations living in Beechwood and EMMA.

Day-to-Day Responsibilities:

- Visits stabilized properties no less than monthly and transitional properties no less than weekly. Assesses the
 general physical condition of the building systems, housekeeping, and grounds. Confirms effectiveness and
 efficiency of property management staff. Identifies and implements improvements to curb appeal and
 marketability.
- Review analysis of building operation expenses and rental revenue and prepare annual operating budgets for entities as required.
- Work closely with the team to connect residents to needed housing resources.
- As requested, prepare and present progress reports to the Executive Director, the board of directors, the Housing Committee, and others.
- Other tasks as assigned related to housing development, policy development, organizational budgets, planning, and administration.

Required Skills/Qualifications:

- Strong analytical abilities, computation, negotiation, and problem-solving skills
- Ability to make public presentations and to work successfully with community groups, government, and private lenders, and low-income tenants
- Strong written and verbal communication skills
- Strong computer skills in various software applications, including MS Office Excel, Word, PowerPoint, and Asana
- Ability to maintain a high level of confidentiality with sensitive information
- Professional appearance and demeanor
- Willingness to manage evening and weekend events periodically
- Knowledge of, or experience with, issues confronting low-income communities and families
- Experience with low-income housing tax credit financing preferred
